ORDER

On August 9, 2016, Crittenden-Livingston Water District ("Crittenden-Livingston") filed a Notice of Election of Use of Electronic Filing Procedures ("Notice") and stated its intent to file, no later than August 31, 2016, an application for a Certificate of Public Convenience and Necessity ("CPCN") and for authorization to issue an evidence of indebtedness.¹ On August 9, 2016, the Commission entered an Order that required, among other things, any party filing a paper to upload the electronic version using the Commission's E-Filing System and to also file an original and six copies in paper medium.²

On August 10, 2016, Crittenden-Livingston filed a motion to amend the Commission's August 9, 2016 Order ("Motion to Amend").³ Per the Motion to Amend, Crittenden-Livingston seeks an amendment of the Commission's August 9, 2016 Order

that will permit it to file only one copy of the plans, specifications, and drawings for its proposed water storage facility.⁴ In support of its Motion to Amend, Crittenden-Livingston stated that, pursuant to 807 KAR 5:001, Section 8, when an applicant makes a timely election of the use of electronic filing procedures, parties must file any papers with the Commission by submitting an electronic copy of the paper using the Commission's E-Filing System and delivering one copy in paper medium to the Commission's offices.⁵

Crittenden-Livingston stated that as a result of the Commission's August 9, 2016

Order, it is required to submit seven paper copies of the plans, specifications, and drawings of its proposed water storage facility. Per Crittenden-Livingston:

Since the plans and drawings are printed on several oversized sheets of paper requiring the use of special printing equipment that Crittenden-Livingston District does not own and that the specifications for the proposed water storage facility are several hundred pages in length, Crittenden-Livingston will incur significant costs to comply with the Order of August 9, 2016. As a small non-profit water district, Crittenden-Livingston District is not as well positioned as other utilities to absorb such costs and had elected the use of electronic filing procedures to reduce the costs of its application.⁷

Crittenden-Livingston also stated that the Commission's August 9, 2016 Order requires it to file five more paper copies of the plans, specifications, and drawings of the proposed plant, equipment, and facilities than it would have to file if it had not elected to

use electronic filings procedures.⁸ Crittenden-Livingston, thus, requests that it be permitted to file only one copy of the plans, specifications, and drawings of the proposed water storage facility in paper medium. On August 19, 2016, Crittenden-Livingston submitted its Application, and the Application contained only one copy of the plans, specifications, and drawings of the proposed water storage facility.⁹

The Commission finds that Crittenden-Livingston would incur significant costs if it were required to file, in paper medium, the original and six copies of its plans, specifications, and drawings of its proposed water storage facility. We find good cause to amend the August 9, 2016 Order to permit Crittenden-Livingston to file, in paper medium, one copy of the plans, specifications, and drawings of its proposed water storage facility in lieu of the original and six copies. We find that Crittenden-Livingston's Application should be considered filed as of the date of this Order.

IT IS THEREFORE ORDERED that:

- Crittenden-Livingston's Motion to Amend is granted.
- 2. Ordering paragraph 3 of the Commission's August 9, 2016 Order is amended to the limited extent that Crittenden-Livingston shall file only one copy of the plans, specifications, and drawings of its proposed water storage facility in paper medium.
- All provisions of the Commission's August 9, 2016 Order that are not in conflict with this Order shall remain in full force and effect.
