ORDER


The matter is before the Commission upon a joint motion filed by Louisville Gas and Electric Company (“LG&E”) and Louisville/Jefferson County Metro Government (“Louisville Metro”) to establish a deadline to file rebuttal testimony of June 16, 2017. In support of their motion, LG&E and Louisville Metro (collectively, “Joint Movants”) note that, pursuant to the Commission’s April 21, 2017 Order, the existing deadline for the filing of rebuttal testimony has been suspended to allow LG&E and Louisville Metro time to resolve the discovery dispute that was the subject of Louisville Metro’s April 20, 2017 motion to compel. Joint Movants state that the discovery dispute has been resolved following the filing of a supplemental response by LG&E on May 26, 2017. Joint Movants both agree that June 16, 2017, would be an appropriate deadline for the simultaneous filing of rebuttal testimony.

Having reviewed the pleading and being otherwise sufficiently advised, the Commission finds that the Joint Movants have established good cause to permit the establishment of a June 16, 2017, deadline for the filing of rebuttal testimony.

IT IS THEREFORE ORDERED that:

1. Joint Movants' motion to establish a June 16, 2017, deadline for the filing of rebuttal testimony is granted.
2. LG&E and Louisville Metro shall file rebuttal testimony on or before June 16, 2017.
3. All other provisions of the Commission's February 27, 2017 Order, which established the procedural schedule in this matter, shall remain in full force and effect.
