ORDER

The matter is before the Commission upon a motion filed by Louisville/Jefferson County Metro Government ("Louisville Metro") requesting that the commencement of the oral argument hearing, scheduled for September 28, 2017, be changed from 9:00 a.m. to 2:00 p.m. In support of the motion, Louisville Metro's counsel states that he has a scheduling conflict the morning of September 28, 2017, and that he is unable to resolve the scheduling conflict. Louisville Metro's counsel informs that he has discussed the possibility of rescheduling the oral argument with counsel for Louisville Gas and Electric Company ("LG&E"). Louisville Metro asserts that LG&E's counsel has agreed to reschedule the starting time of the September 28, 2017 oral argument hearing from 9:00 a.m. to 2:00 p.m.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Louisville Metro has established good cause to permit the rescheduling of the September 28, 2017 oral argument hearing. Accordingly, the start of the September 28, 2017 oral argument hearing is changed from 9 a.m. to 2 p.m.

IT IS THEREFORE ORDERED that:


1. Louisville Metro's motion to amend the commencement of the oral argument hearing on September 28, 2017, is granted.

2. The start of the September 28, 2017 oral argument hearing shall be changed from 9 a.m. to 2 p.m.

3. An evidentiary hearing, if requested by the parties or on the Commission's own motion, shall be scheduled for Friday, September 29, 2017, at 9:00 a.m., Eastern Daylight Time, at offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.


4. Pursuant to KRS 278.360 and 807 KAR 5:001. Section 9(a), a digital video transcript shall be made of the hearing.
