Wal-Mart shall comply with all provisions of the Commission's regulations,
807 KAR 5:001, Section 8, related to the service and electronic filing of documents.


4. Wal-Mart shall adhere to the procedural schedule set forth in the Commission's December 13, 2016 Order and as amended by subsequent Orders.
