ORDER

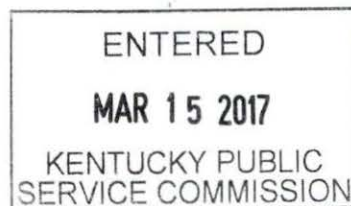
On March 8, 2017, Kentucky Utilities Company and Louisville Gas and Electric Company jointly filed a motion requesting the scheduling of an informal conference with the Commissioners, Commission Staff, and all parties to discuss the procedures for conducting settlement discussions and the Commission's review of any resulting settlement agreements or stipulations. By Order entered on March 10, 2017, the Commission granted the motion and scheduled an informal conference to be held on March 28, 2017. The Attorney General's Office of Rate Intervention ("AG") then filed on March 14, 2017, a response to the motion objecting to the attendance of the Commissioners at an informal conference.

Based on the AG's response, which will be treated as a request for rehearing, the Commission will modify its March 10, 2017 Order to the limited extent that the discussion of the procedures for conducting settlement discussions and the

Commission's review of any resulting settlement agreements or stipulations will be held during a hearing rather than during an informal conference.

IT IS THEREFORE ORDERED that the March 10, 2017 Order is modified to the limited extent that a hearing shall be held on Tuesday, March 28, 2017, at 1:00 p.m. Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purposes of discussing among Commissioners, Commission Staff, and counsel for participating parties the settlement discussion procedures and the Commission's review of any resulting settlement agreements or stipulations.
