In accordance with 807 KAR 5:001, Section 8, Duke Energy Kentucky, Inc. gives notice of its intent to file an application for Gas Cost Adjustment with the Public Service Commission no later than March 10, 2016 and to use the electronic filing procedures set forth in that regulation.

Duke Energy Kentucky, Inc. further states that:
