Further Affiant sayeth naught.



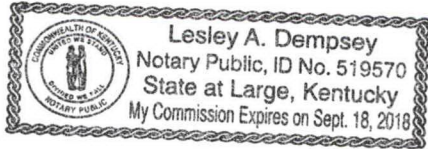
