RE: Cumberland Valley Electric, Inc.
Case No. 2016-00169 - Filing Deficiencies

The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

- (1) 807 KAR 5:001: Section 16(1)(b)(4) – New or revised tariff sheets, if applicable, shown by either providing the present and proposed tariffs in comparative form on the same sheet side by side or on facing sheets side by side, or providing a copy of the present tariff indicating proposed additions by italicized inserts or underscoring and striking over proposed deletions. **Prepaid Tariff not included in markup or proposed tariff.**
- (2) 807 KAR 5:001: Section 17(4)(b) – The present and proposed rates for each customer class to which the proposed rates will apply.
 - **Remote reconnect not included in notice**
 - **Notice does not reflect the appropriate rate at which off-peak usage will be billed for current off-peak marketing residential customers**

- (3) 807 KAR 5:001: Section 17(4)(c) – Amount of change requested in dollar amounts and percentage change for each customer classification to which change will apply. **Proposed percentage increase for remote disconnect not correct.**
- (4) 807 KAR 5:001: Section 17(4)(d) – Electric, gas, and water utilities – the amount of the average usage and the effect upon average bill for each customer class to which change will apply. **Average usage not included in notice.**
- (5) 807 KAR 5:001: Section 17(2)(b) – While Applicant states in its Application that it gave notice of the proposed rate increase, the Application does not state whether notice was provided by including notice with customer bills, mailing written notice of each customer, publishing notice in a newspaper of general circulation, or publishing notice in a trade publication or newsletter. Further, the Application does not state the date(s) that notice was provided and how said dates complied with notice provisions of 807 KAR 5:001: Section 17(2)(b).

The statutory time period in which the Commission must process this case will not commence until the above-mentioned required information is filed with the Commission. You are requested to file this information within 10 days of the date of this letter.
