Pursuant to Commission Staff's June 10, 2016 notice, an informal telephonic conference ("IC") was held in this matter on June 10, 2016, at the Commission's office in Frankfort, Kentucky. A list of attendees is attached hereto.

The purpose of the IC was to discuss certain filing deficiencies in Cumberland Valley Electric, Inc.'s ("Cumberland Valley") application for an adjustment of rates. During the teleconference, Commission Staff ("Staff") discussed the identified filing deficiencies in detail with Cumberland Valley and informed Cumberland Valley that a deficiency letter would be issued by Staff later the same day. The deficiencies discussed during the conference are accordingly identified by letter from Staff dated June 10, 2016, notifying Cumberland Valley that its application was rejected for filing, listing the deficiencies, and instructing Cumberland Valley to provide additional information within ten days.

Finding that no party had any further questions the conference was adjourned.
