Application of Licking Valley Rural Electric Cooperative Corporation for a General Rate Increase

Pursuant to Commission Staff Notice issued on August 16, 2016, a telephonic informal was conducted on August 17, 2016. The purpose of the informal conference was to discuss the filing deficiencies associated with Licking Valley Rural Electric Cooperative Corporation's ("Licking Valley") base rate application.

- For the deficiencies (1) and (2) of Commission Staff's August 11, 2016 letter relating to new or revised tariff sheets, file revised exhibits B and C to correct:
 - Proposed tariff and comparative tariff sheet 5 lists a 62 watt LED. The current filed tariff sheet lists a 68 watt LED.
 - Proposed tariff and comparative tariff sheet 6 lists two party pole ground attachment at \$0.29. The current filed tariff sheet lists a two party pole ground attachment as \$0.27.
 - Comparative tariff sheet 5 lists the 30 foot wood pole cost as \$3.54. The current filed tariff sheet lists a 30 foot wood pole as \$3.37.
 - No proposed or comparative Rules and Regulations Sheet 19 with the return check charge increase.
 - No proposed or comparative sheet 31 listing the proposed prepay rates for Rate Schedules A and B.
- For deficiencies (3) and (4) relating to the past two annual reports to members and the December 2014 monthly managerial report, Licking Valley will submit the materials to cure the deficiencies.
- For deficiencies (5) and (6) relating to the customer notice, Licking Valley will need to publish a corrected notice of with the following corrected information:

- Rate Schedule B (prepay) should be on the notice under present and proposed rates.
- The dollar change for Schedule B, Commercial and Small Power should be \$8.20.
- The dollar and percent change for Schedule SL, Security Lights should be \$0.50 and 5.0%, respectively.
- The dollar and percent change for Schedule A, Residential, Schools and Churches (prepay) should be \$5.56 and 5.7%, respectively.

There being no further discussions, the informal conference was adjourned.
