## NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

In accordance with 807 KAR 5:001, Section 8, Duke Energy Kentucky, Inc. gives notice of its intent to file an application for <u>CPCN for dry Bottom Ash Conversion at East Bend</u> with the Public Service Commission no later than <u>Duke Energy Kentucky</u>, Inc. and to use the electronic filing procedures set forth in that regulation.

Duke Energy Kentucky, Inc. further states that:
