Dear Public Service Commission,

In my last KU bill I was informed of the proposed rate increase. I'm writing to you to please ask that you not approve this increase.

-The rates already seem somewhat high. I myself live in a newer home, use all the energy conserving measures recommended and find my bill to be on the high side. Unfortunately, there are people that live in older homes, that even if trying to implement energy efficiency, will be unable to will this losing battle with energy prices.

-Many people in our community live on fixed incomes. The increases these individuals receive in their income are quite meager when compared to the rate increased proposed by the utility company.

-I work in health care and can personally attest to what a financial hardship utility costs already place on a lot of people within our community. It is a sad day when one seems

someones health decline because they don't take their medication on a regular basis, often because they couldn't afford their medication. These aren't people driving around in luxury cars, these are people that often don't get their medication because they had to buy food and pay heating bills.

-Electricity shouldn't be treated like a luxury item with unreasonable rate hikes when utility companies want more of a profit margin. This is one of the most basic needs for many individuals; again, it is not as if the people are writing to you because someone is going to deprive them of a luxury vacation; many people just don't want to make the choice between groceries and heat.

-Shame on KU for several reasons:

- The notice of a potential rate hike should have come out long before it did.

- This increase isn't just a small percentage, it's quite high when one considers that many of us go with no income raises or very small ones such as 1%. Why can't KU live like their customers and ask for a reasonable increase like one percent?

- In the letter KU acts as if the increase will be only a small raise to residential customers. Surely, KU isn't so short sighted to know that an increase such as this will lead to more than just an increase on our utility bills, it will raise prices within the community because businesses will have to offset the cost to customers.

I ask that you not allow an increase of this size. If there is any increase it should be a conservative one. Since this is a public need we all pay for it would be good to know just how much the employees are making at KU; even if an increase is implemented, it would be a crying shame to think that the executives get to pad their pockets while other lower ranking employees see little to no pay raise. I'm aware they asked for confidentiality regarding the pay of employees, but it is not as if we are asking for names; they list 31 jobs in senior management, but couldn't say the average pay of these individuals. Something sure does seem suspicious with the secrecy of their documents submitted to you.

Please don't allow for this increase.
