After that it has backed up twice and the last time Bullitt Utilities did fix that and have had 1 toilet overflow. I believe that the previous owners should be liable for all cost because they have taken all residents money over the years and not kept up the sewer. I do understand that the cost should go up, but 63 percent at a time is a bearing on all concerned.
