**MOTION FOR EXTENSION OF TIME**


Muhlenberg County Water District #3 (“MCWD3”) hereby moves the Kentucky Public Service Commission (the “Commission”) for an extension of time through and until Friday, March 10, 2017, in which to file responses to the Commission Staff’s First Request for Information. In support of its motion, MCWD3 states:

MCWD3 was previously represented in this case by different counsel. The requested extension of time is necessary because MCWD3’s current counsel was only recently hired. Further, Item 4 of the Commission Staff’s First Request for Information requires MCWD3 to provide information that must be obtained from its supplier, Central City. Because MCWD3 is unsure how long it will take to receive information from Central City, this extension of time is necessary. This Motion for Extension of Time is not made for the purpose of unduly delaying the Commission’s examination and, if granted, will not prejudice the Commission’s ability to conduct its examination.

**WHEREFORE**, MCWD3 respectfully requests that the Commission issue an order granting an extension of time through and until Friday, March 10, 2017, to file responses to the Commission Staff's First Request for Information.
