We are writing on behalf of Appalshop, Inc., our local and regional partners, and citizens affected by the rate increase proposal of AEP. Appalshop, Inc. is located in Whitesburg, Kentucky and was founded nearly 50 years ago. Located in the heart of the central Appalachian coalfields, Appalshop houses media production and training facilities in film and video, a community radio station, a 150-seat theater, art gallery, and regional archive of over 4000 hours of film, audio recordings, and still images. Appalshop is a private, non-profit organization (designated as a 501(c) 3 organization by the IRS) supported with funds from public agencies, foundations, corporations, and individual donors.

We are writing due to our deep concern regarding the impact of the proposed AEP rate increase on our organization, as well as the local, regional community, and economy at large. In recent years, fundraising for non-profit organizations has become a challenging and competitive venture, requiring us to make budget cuts to even the most essential programming. We adhere to tight budgets and conservative spending, thus we have analyzed how the AEP proposal will increase our utility bills and find the proposal disconcerting and financially troubling to us. Each year, Appalshop contributes between \$1.5 to \$2 million into the local economy through salaries and programming. To absorb these potential increases, Appalshop would have to make difficult decisions, impacting not only the organization but also the region, as we prioritize staffing and programming moving forward.

As a long-standing local non-profit, we are also concerned for our regional partners and citizens. Eastern Kentucky, and especially coal communities, is suffering from years of economic decline, resulting in increased unemployment, and difficult economic decisions for everyone. The AEP proposal is a deep cut to an already hurting economy. Monthly bills will soar, and to our many citizens who live on fixed incomes, it will become unbearable. AEP's utility bills are already unacceptably high; this proposal will undercut recent efforts to stabilize and improve regional economies.

I want to thank the Public Service Commission for convening and granting my request of this public hearing in Kentucky Power's service territory so that the Commission can hear firsthand from the citizens that will be impacted by this devastating rate increase. As Floyd County Judge Executive, I am asking the Public Service Commission to fully reject AEP Kentucky Power's \$64 million/16 percent rate increase for the roughly 168,000 customers in the 20 county service areas.

The last decade has been a challenging time for the economy of Eastern Kentucky. The assault on the coal industry has resulted in the loss of many coal related jobs. The counties of Kentucky Power's service territory have some of the highest poverty rates in Kentucky and the nation. Many have left the region to find employment elsewhere. Many of those that chose to stay are on fixed incomes and cannot afford nor should they be expected to make up for Kentucky Power's lost revenue. Ky. Power has yet too adequately demonstrate how it is reducing cost before placing <u>ALL</u> of the burden on customers.

It is ridiculous, obscene, and unconscionable to expect Kentucky Power's customers to be asked to make Kentucky Power whole for the decline in the economy when Kentucky Power is one of the main contributors for such a loss in their service territory. Kentucky Power says they need a rate increase to make up for the loss of customers and the general decline in electrical use as well as the costs of dismantling the Big Sandy 2 facility. There is no logic in that argument. It is a downward spiral. Higher rates mean many customers will be forced to find ways to use less electricity or turn to other sources of energy. Kentucky Power brags about promoting economic development but higher rates will make Eastern Kentucky less competitive to attract new industry or encourage business expansion. As the economy continues to decline from the lack coal production and sales, will Kentucky Power come back in a few years and ask for another rate increase. The rates they are requesting will take \$64 million a year out of the pockets of their customers as well as the local economy. Higher rates will not contribute to economic recovery of Eastern Kentucky but will hinder diversification from the coal economy to other industries and businesses. Sadly, if this increase is granted, Kentucky Power would have the highest base rates in the entire state. Eastern Kentucky would be paying the most. All of this is happening when we are struggling to recruit those industries and businesses. In order for us as a region to compete and diversify our economy, we should be the least expensive not the highest.

It appears that Kentucky Power is asking for these rate increases in order for their shareholders to maintain the same level of profits they have been receiving, all the while this is being put on the backs of those who can least afford it. Since 2005 Kentucky Power has been granted three rate increases of almost 6% a year for residential customers for a total of over 51%...

They were given permission to shut down our largest power plant, the Big Sandy 2, which meant the loss of over 2 million tons a year in sales of central Appalachian Ky. coal, the loss of 150 direct jobs at the plant, as well as all the coal related jobs that were associated with those sells. To replace it Kentucky customers were asked to take a 50% interest in almost identical plant in Moundsville, West Virginia that had already been paid for by AEP's Ohio utility customers.

Kentucky Power is not a stand-alone utility. It is a subsidiary of American Electric Power. Expenses of Kentucky Power are supposed to provide adequate electric service, but profits flow to AEP. AEP is one of the largest electric utilities in the US serving 5.4 million customers in 11 states. In this case Kentucky Power is attempting to coerce its customers to pay for AEP's corporate aviation costs. Kentucky Power customers do not understand why they are being asked to pay more for their electricity while the CEO of AEP made over \$11 million in annual compensation for 2016 and AEP stock has doubled in value since the last Kentucky Power rate increase in 2014. All the while Eastern KY citizens are being forced to cut spending in their own households. Ky Power wants to continue to spend away and place their burden on an already impoverished group of people.

I implore this commission to think about the people who can least afford this rate increase. The "BIG CORPORATIONS"seem to have a stronger voice now in our State and Federal government than our "people" have.

You have a responsibility and an opportunity to aid the people who are suffering and who need your help.

Let's not reward Corporate Greed but hold them accountable.

I respectfully ask this Commission to deny the rate increase

This letter is written out of great concern for the impact that the proposed rate adjustment from Kentucky Power would have on Red Bird Mission, Inc., Red Bird Housing, Inc. and other citizens who reside within the surrounding area of southeastern Kentucky. The proposed rate adjustment is expected to increase our electricity bill from 18%-40%, depending on our buildings. We estimate this to increase our total annual bill by as much as \$24,000.00 at our current rate of use. In 2016 we paid Kentucky Power \$221,712.92. The Red Bird Mission serves around 9,000 people in the under-served areas of Bell, Clay, and Leslie counties. We provide emergency food, clothing assistance, a baby pantry, employment opportunities and home repair just to name a few of our ministries for the needy. We have an eight (8) unit apartment for elderly and disabled. We educate 250 children in our pre-K-12 school. It costs us more than \$7,000 a year to provide the quality education for each child, but because of the high rate of poverty we charge no more than \$610.00 a year tuition. Our sliding fee scale allows the most impoverished families to pay as little as \$0.00. We essentially operate our entire Mission from the kindness of others who donate their money and time to address the needs of people in this area. As with many non-profits, we are suffering a decline in charitable giving. This rate adjustment will have a serious impact on our ability to help the community, resulting in a loss of much needed resources for the children and families in this isolated area of Appalachia. We ask that you consider this when making your decision to act on Kentucky Power's request and we prayerfully hope that the rate adjustment request is declined.
