As a customer of Commercial Propane living on Old Bridge RD, I wish to offer three points for you to consider when deciding on their rate request (Case # 2017-00343).

- My home uses propane for heat only. As such, for May, June, July, August, September, and October I pay \$18.21 each for 400 cubic feet of gas I never use. Then when the cold weather begins I pay for those 2000 cubic feet all over again (contrary to Commercial Propane's claim). This summer, I closed the gas valve going into my meter and did not open it until the end of October; before opening my gas valve I photographed my meter. Sure enough the next bill showed the beginning meter reading just as the meter sat all summer meaning they billed for 2000 cubic feet twice equaling \$91.05.
- 2) My experience is that Commercial Propane only reads meters 7 times a year which should save them some operating expense.
- 3) During the extreme cold we experienced this year the gas pressure to my home has often been too low for my upper-floor furnace which is in the attic. The low pressure caused the

RECEIVED By Kentucky PSC at 2:35 pm, Feb 28, 2018 furnace not to ignite, the condition is only temporary but the temperature in the house drops until I manually cycle the furnace off and on to get it to ignite. To be fair, my house is geographically the farthest from the neighborhood tank.
