COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO  
MONROE COUNTY WATER DISTRICT

Monroe County Water District ("Monroe District"), pursuant to 807 KAR 5:001, is to file with the Commission the original with ten copies in paper medium and an electronic version of the following information. The information requested herein is due on or before Wednesday, September 20, 2017, with the filing of witnesses and exhibits pursuant to the Commission's Order of August 18, 2017. These requests shall be deemed continuing so as to require further and supplemental responses if Monroe District receives or generates additional information or changes within the scope of these requests between the time of the response and the time of the hearing on September 27, 2017, at 10:00 a.m. Eastern Daylight Time. Responses to requests for information in paper medium shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.


Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be

accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Monroe District shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Monroe District fails or refuses to furnish all or part of the requested information, Monroe District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Monroe District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

  - b. State the legal expenses incurred to date; and
  - c. State the amount of rate case expense incurred to date that is associated with professional accounting services. Provide a copy of each invoice for professional accounting services for the rate case.
