ORDER

On April 24, 2017, Elkhorn Water District ("Elkhorn") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission notes that in its 2016 Annual Report Elkhorn reported a water loss of 15.2338 percent.² Elkhorn's application provides updated purchases and sales information for a more current period than the 2016 Annual Report. Commission regulation 807 KAR 5:066(6)(3) states that "for rate making purposes a utility's unaccounted-for water loss shall not exceed fifteen (15) percent of total water produced and purchased, excluding water consumed by a utility in its own operations." Based upon the updated information in the application and the percentage of other water consumed by the utility in its 2016 Annual Report,³ Elkhorn's unaccounted-for water determined updated period.⁴ loss is to be 19.5333 percent for the

Reduction of Elkhorn's unaccounted-for water loss to 15 percent would result in an approximate \$7,527⁵ decrease to purchased water expense. Potentially, Elkhorn is paying \$0.15 per 1,000 gallons sold for expenses associated with unaccounted-for water loss in excess of the allowable 15 percent⁶ threshold.

The Commission is placing greater emphasis on monitoring utilities that consistently exceed the 15 percent unaccounted-for water loss threshold and strongly encourages Elkhorn to pursue reasonable actions to reduce its unaccounted-for water loss. Failure by Elkhorn to make significant process towards reducing unaccounted-for water loss may cause the Commission to pursue additional action with the utility.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Elkhorn purchases water from Frankfort Electric Water & Plant Board ("Frankfort").

2. Frankfort increased its wholesale rate to Elkhorn from \$2.35 per 1,000 gallons to \$2.45 per 1,000 gallons effective November 1, 2016.⁷ Elkhorn proposes to increase the water rates to its customers effective May 1, 2017, to reflect the increased cost of purchased water.

Elkhorn proposes a purchased water adjustment factor of \$0.27 per 1,000 gallons.

4. Elkhorn requests a deviation from 807 KAR 5:068, Section 1(5), establishing the definition of the supplier's base rate as the rate in effect immediately prior to the most recent increase. Elkhorn did not pass through Frankfort's November 15, 2015 wholesale rate increase from \$2.25 per 1,000 gallons to \$2.35 per 1,000 gallons.

5. During the 12 months ended December 31, 2016, Elkhorn purchased 67,773,000 gallons of water from Frankfort. During the same period, Elkhorn sold 51,891,489 gallons of water. The increase in the cost of purchased water is \$13,554.60, resulting in a purchased water adjustment factor of \$0.27 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.27 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just and reasonable and should be approved.

7. Elkhorn's rates proposed in the application should be approved.

8. The rates as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service rendered by Elkhorn on and after May 1, 2017.

IT IS THEREFORE ORDERED that:

1. Elkhorn's request to deviate from 807 KAR 5:068, Section 1(5), is approved.

2. The purchased water adjustment factor of \$0.27 per 1,000 gallons is approved.

3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Elkhorn on and after May 1, 2017.

4. Within 20 days of the date of this Order, Elkhorn shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
