ORDER

On September 6, 2017, the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("Attorney General"), filed a motion requesting a limited extension of time to file supplemental requests for information to Kentucky Power Company ("Kentucky Power") relating to the Attorney General's Initial Data Request, Item Nos. AG-140 and 1-141. The Attorney General states that his supplemental data requests related to all other items will be filed by September 8, 2017, pursuant to the existing procedural schedule, but that an extension is needed for the specified requests.

As a basis for the motion, the Attorney General states that Deloitte and Touche, LLP ("Deloitte"), an internal auditor for Kentucky Power, American Electric Power ("AEP"), and AEP Service Company, asserts that the documents requested in AG 1-140 and 1-141 are proprietary to Deloitte and can only be viewed in one of Deloitte's offices.

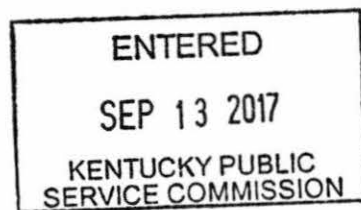
The Attorney General further states that counsel for Kentucky Power is arranging an inspection of the documents at one of Deloitte's offices within the next few working days. However, an inspection cannot be arranged until after the September 8, 2017 due date for the supplemental data requests.

The Attorney General states that he has reached an agreement with Kentucky Power for the Attorney General to file supplemental requests within five days following the inspection of the documents that Deloitte maintains are proprietary. Under this agreement, Kentucky Power would file its responses within five days of the Attorney General's filing of its supplemental requests. The Attorney General states that Kentucky Power has no objection to this motion for an extension of time.

The Commission, having considered the Attorney General's motion, finds that the Attorney General has established good cause and that the Attorney General's motion for an extension of time should be granted.

IT IS THEREFORE ORDERED that the Attorney General shall be granted an extension of time until September 22, 2017, to file supplemental requests for information relating to the Attorney General's Initial Data Requests, Items AG 1-140 and 1-141.
