#### <u>ORDER</u>

On December 22, 2017, the Commission issued an Order requiring Kentucky Frontier Gas, LLC (Kentucky Frontier) to submit (1) detailed reports for each upcoming year summarizing the Pipeline Replacement Program (PRP) projects in that year by December 31 each year, and (2) a detailed report listing actual PRP projects completed during the previous year at the same time as its Annual Report. Kentucky Frontier did not file its upcoming year report prior to 2023 or 2024 and did not file its project completion report following 2022 or 2023.

The Commission finds that Kentucky Frontier should file a detailed report summarizing the PRP projects planned for 2024 and a detailed report listing actual PRP projects completed during 2022 and 2023. Kentucky Frontier should also explain why it has not filed the required documents.

IT IS THEREFORE ORDERED that:

1. Within 30 days of the service of this Order, Kentucky Frontier shall file a detailed report summarizing the PRP projects planned for 2024 and a detailed report listing actual PRP projects completed during 2022 and 2023.

2. Within 30 days of the service of this Order, Kentucky Frontier shall provide an explanation why it did not timely file the required documents.
