### ORDER

On July 27, 2017, Magoffin County Water District ("Magoffin County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup> By letter dated August 3, 2017, the Commission notified Magoffin County that its application was rejected as deficient. On September 25, 2017, Magoffin County filed its responses to the filing deficiency and its application was accepted for filing.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Magoffin County purchases water from the city of Salyersville ("Salyersville").
- 2. Salyersville notified Magoffin County that its wholesale rate would increase from \$2.65 per 1,000 gallons to \$2.73 per 1,000 gallons effective August 1, 2017.<sup>2</sup> Magoffin County proposed to increase the water rates to its customers effective September 1, 2017, to reflect the increased cost of purchased water from Salyersville.

- 3. Magoffin County proposes a purchased water adjustment factor of \$0.10 per 1,000 gallons.
- 4. During the 12 months ended June 30, 2017, Magoffin County purchased 190,026,660 gallons of water from Salyersville. During the same period, Magoffin County sold 152,743,900 gallons of water. The increase in the cost of purchased water is \$15,202.13, resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.10 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved as requested by Magoffin County.
- 6. Magoffin County's proposed rates, as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service rendered by Magoffin County on and after September 1, 2017.

## IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.10 per 1,000 gallons is approved.
- The rates as set forth in Appendix B to this Order are approved for water service rendered by Magoffin County on and after September 1, 2017.
- 3. Within 20 days of the date of this Order, Magoffin County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
