ORDER

On May 17, 2018, Atmos Energy Corporation (Atmos) filed a Petition for Rehearing (Petition) of the Commission's May 3, 2018 final Order pursuant to KRS 278.400. The Commission issued an Order granting Atmos's Petition on June 4, 2018, and set forth a procedural schedule to be followed. The June 4, 2018 Order required Atmos and any Intervenors to either file a request for a hearing or file a statement that the case may be submitted for a decision based on the existing record no later than July 31, 2018. The Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention, filed a recommendation for the case to be submitted upon the record on July 31, 2018. As of the date of this Order, Atmos has not filed a request for a hearing or a statement that the case can be submitted based upon the existing record.


IT IS THEREFORE ORDERED that:

1. Atmos shall file a request for a hearing or file a statement that the case may be submitted for a decision based on the existing record no later than August 27, 2018.
2. All other provisions of the June 4, 2018 Order shall remain in full force and effect.
