

Pursuant to a Commission Order issued on May 5, 2017, an informal conference was held on May 18, 2017, at the Commission's offices in Frankfort, Kentucky. The purpose of the informal conference was to discuss any and all issues related to the instant show cause proceeding against Kentucky Utilities Company ("KU"). A list of the attendees is attached hereto.

Commission Staff began the meeting by stating that the purpose of the informal conference was to discuss the show cause proceeding against KU. Giving rise to the show cause proceeding is the November 21, 2016 incident involving Marcus Hobbs, a member of the public.

Commission Staff and representatives of KU discussed the incident, including any post-incident measures taken by KU to address potential safety concerns related to the incident. Commission Staff and KU were able to reach an agreement in principal. Commission Staff will prepare a draft of the Stipulation and Settlement Agreement and will forward to counsel for KU to review.

There being no further discussions, the informal conference was adjourned.
