To whom it may concern,

I am an individual investor who sadly originally invested \$400,000.00 with Forexco to be a partner in the drilling of a natural gas well in Bell County Kentucky. I was promised a great return on the investment which occurred for about a year. After several years they "converted" my part ownership of the well to a shareholder of Citienergy without my consent. They used profits from the gas sales to build a pipeline which I have no ownership of but had to help build. They combined all revenues together for all of Bell county wells even though I only bought into the drilling of one well. They consistently are vague on what management fees are going towards . I read your latest orders online for 5/30/2017 for information. I believe this whole company is a scam operation to line pockets of the president Daniel Forsberg, Paddock Oil (who I don't know who owns) and their business connections. I am not aware of any investor receiving a dime from their ventures in years except the president and his family who are taking what little profit there may be putting it into "management fees". I know that my

investment is lost but please don't allow this company to do business in your state. They are not above board with their investors and it does not appear they are with the Kentucky Public Service Commission. I do not have the resources to get to the bottom of what they are doing but I hope you can uncover their secretive business dealings. I would like this letter to go to the powers that be in the governors office to investigate this company and their business dealings.
