Please accept this filing on behalf of my client, Mercer County Sanitation District, to address your Notice of Filing Deficiencies letter dated April 12, 2017, in the above-referenced case. I have been retained as counsel for the Mercer County Sanitation District. I do not represent Red Barn Waste Management, LLC.

My client, Mercer County Sanitation District, would like to join in the application of Red Barn Waste Management, LLC for Commission approval to Transfer Ownership and Control of a jurisdictional utility to the Mercer County Sanitation District. The application of Red Barn Waste Management, LLC was originally submitted to the Commission on April 7, 2017.

Per review of the Kentucky Secretary of State's website, Red Barn Waste Management, LLC, a Kentucky Limited Liability Company, is managed by managers not members. It has a single manager, Jeffrey C. Rutenberg. Red Barn Waste Management, LLC, was organized on December 21, 2005 in Kentucky. To the best of my knowledge, Red Barn Waste Management, LLC, was administratively dissolved by the Kentucky Secretary of State on September 28, 2013.

Pursuant to KRS 278.020(6) and KRS 278.020(7) the Mercer Sanitation District prays that the Commission grant approval of the proposed acquisition.
