NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

(Complete All Shaded Areas and Check Applicable Boxes)

In accordance with 807 KAR 5:001, Section 8, <u>Monroe County Water District</u> gives notice of its intent to file an application for <u>approval of certain accounting adjustments</u> with the Public Service Commission no later than April 28, 2017 and to use the electronic filing procedures set forth in that regulation.

Monroe County Water District further states that:

- It requests that the Public Service Commission assign a case number to the intended application and advise it of that number as soon as possible;
- 2. It or its authorized representatives have registered with the Public Service Commission and x are authorized to make electronic filings with the Public Service Commission;
