Pursuant to Orders issued on November 20, 2017, and November 29, 2017, informal telephonic conferences were held on November 21, 2017, and December 1, 2017, respectively, at the Commission's offices in Frankfort, Kentucky. The informal telephonic conferences were held at the requests of the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and Kentucky Power Company ("Kentucky Power"). Both requests were made for the purposes of discussing the availability of witnesses and the need for any particular witness to attend the evidentiary hearing in this matter, which was scheduled to commence on December 6, 2017. An attendance sheet is attached to this memo.

At both conferences, the various parties to this matter informed as to the availability of their witness(es) to appear at certain days during the evidentiary hearing, which was scheduled to commence on December 6, 2017. The parties also discussed which Kentucky Power witness and which of the intervenors' witness would need to attend the hearing for purposes of cross-examination.
