AEP crooked the KSPC and Ky power customers in to buying the $\frac{1}{2}$ Mitchel power in W.Va. Also paying for #2 Generating unit at Big Sandy power plant. Aep made the decision to shut the Big plant down them self.

AEP has a 15 year plan including shutting down 5 to 7 more coal fire plants.

KSPC or Ky power customers did not make this decision. AEP should have to reap the loss of these 2 bad decisions.
