## To Whom It May Concern:

I'm writing to the Kentucky Power rate increase case. As a Kentucky Power Customer, I'm strongly opposed to another increase by the electric company. For one, besides the obvious aspect that I do not wish to pay more I think that is a poor implementation to fix a poor business model. I think that the Kentucky Power needs to alter their business operations in order to generate more revenue. Increasing sales price doesn't necessiarly constitute or guarantee an increase in revenue. Sure after this is implemented they will make more money first few business cycles then people start realizing the increase they are going to adapt. People adapt over time, they will seek more energy efficient alternatives, use less energy, or switch to an alternate form of energy (solar, fire wood, coal). This is basic Economic 101 stuff, no different than if Marathon Oil Refinery takes a drastic increase in gas prices. They will make more money in the very short term, long term as people are hurt/effected they will buy more efficient smaller cars, move closer to work, drive less or use an alternative mode of transportation. So guess what happens to the massive amount of revenue they were making? They are right back to making the same amount. They need to figure out better ways to make more revenue. Either gain more customers, cut costs, quit the subsidies. I don't know why the power company subsidizes a more efficient thermostat, appliance, home efficiency inspection, light bulb rebates, etc. In the end people use less power which means less revenue. People want to be more efficient then they need to invest in it themselves, not the power company which in turn passes that cost on to me! It is not a sustainable business model, offering customers ways to use less of your product is not sustainable and because it is not sustainable I don't know why your customers should be at the mercy of your wasteful business practices.

If they raise the price I'm going to use less electricity by:

- 1. Cut back by not using as much.
- 2. Invest in more appliances and other things that use even less electricity.
- 3. Burn more firewood than I already do now.
- 4. Start investing in solar ( then I won't need their business, and Kentucky Power can buy my surplus, more unsustainable business practices)

So by taking the steps above how much more revenue do you think they will actually make off me? Not much, now consider if everyone that can afford to starts doing these things. They will be right back in this meeting room begging for a rate increase.
