To Whom It May Concern;

KU has notified its consumers that have filed a request for a rate hike. KU indicates that this increase is necessary to improve infrastructure. We would ask that the PSC seriously consider the motivation for KU's request.

Based on online information, there have been rate increases of 7.9% in 2013, 9.6% in 2014, 2.1% in 2015, 5.94% in 2016, and 3.34% in 2017. And while these may, at first glance, seem somewhat reasonable, in

order to truly grasp the situation, one must also look at other factors that effect KU's revenue stream.

Consider the fact that KU has decreased its customer voluntary throttling of service during peak periods rebate by half, the fact that KU doubled its customer service fee (a fee that seems to be charged to a customer

for the privilege of being a customer), and received a reduction in their tax burden with the Tax Cuts and Jobs Act (TCJA). Granted a portion of those savings were passed on to the consumer at rate determined by

statute, but KU still achieved a considerable reduction overall. Also, higher than anticipated off system sales

for KU generated increased revenues but did not effect costs paid by KU customers. (An attempt to force 'smart' meters onto the consumer at a cost of 350 million was reject, for which all consumers should thank the

PSC.) And this doesn't even address a nearly 38% increased service area acquired by KU in recent years.

Consider also the annual reports issued by KU to its shareholders in that same period. In 2013

revenue in millions was 1.512 a 52 million increase over 2012 , in 2014 it was 1.625 or a 113 million increase,

2015 posted 1.737 or 112 a million increase, 2016 was 1.832 a 95 million increase, and in 2017 a 1.926

increase equated to 94 million in additional revenue. (And it should be noted that these amounts reflect only

the revenues for KU, a single entity of the larger parent company LL&G)

Now to the current request. KU is requesting an 8.1 % increase, which based on COLA is a

significant ask. However, they are also requesting abatement of the customer portion of the TCJA, which totals a 3.6% amount making the actual revenue increase for KU 11.7%.

Based on past request and rate hikes since 2013 and looking at KU's public statements to its

shareholders in that same period, KU is engaging in a systematic effort to raise rates through secondary and

tertiary charges while attempting to convince the PSC that annual rate hikes are also needed. Based on the

annual increases in revenue posted by KU and given past increases in actual rate hikes as well as the covert

increases such as the doubling of the service fee abatement of the TCJA, and reduction in the energy sharing

credit , the actual increase to the consumer is not only staggering in its scope and usurious in size, but out of all

proportion to any reasonable increases for legitimate reasons that ought to be considered by the PSC.

In the interests of public transparency as well as fundamental fairness to the consumer, we would

request that you reject the current request for a rate hike by KU.

Apologize for being late with this email regarding Kentucky Utilities Company request for adjustment of its rates and charges to become effective on and after November 1, 2018. My reason for being late is because of Hip Revision surgery performed on October 15, 2018. I have not yet seen any decision by the PSC on KU's request.

As a retired former business executive, it is appalling to me that KU is proposing a total increase of 11.7% in monthly residential electric bills. One can understand reasonable increases due to inflation and / or needed capital expenses but the amount requested, if necessary, implies poor management and lack of cost control.

I should point out that I am a shareholder in PPL Corp., KU's parent company, and would probably benefit in the short term from the proposed increase. However, as mentioned above, a request for such a large increase raises concern about company management and the long term success of the firm. If KU was not a public utility company, it is very doubtful that such a large increase would be accepted by the firm's customers.

Assuming the decision on the request has not yet been made, I urge the PSC to closely scrutinize KU's reasons for the increase and hopefully reduce the amount of the requested increase.

Ladies and Gentlemen:

This public comment is submitted by Phoenix Paper Wickliffe LLC ("Phoenix Paper") in connection with the proposed adjustment of rates and charges by Kentucky Utilities Company ("KUC"), which proposed adjustment is the subject of Public Service Commission Case No. 2018-00294.

Phoenix Paper is owned by Global Win Wickliffe, LLC ("Global Win"), a subsidiary of Shanying Paper International. In August of 2018, Global Win acquired the paper mill in Wickliffe, Kentucky that had previously been operated by Verso Paper and which has been idled for the past two years. Phoenix Paper has announced its intention to invest up to \$150 million in the paper mill and to hire up to 500 employees, which would make it one of the largest employers in western Kentucky and bring back job opportunities to a community in need of economic growth.


The paper mill is located within KUC's territory, and existing electricity rates were a key consideration in the decision to reopen the paper mill and make these significant investments in the company and the community. In September of 2018, shortly after the announcement of the acquisition of the paper mill, the proposed investments and the signing of a contract for electric service between KUC and Global Win, KUC announced its intention raise rates. After discussions with KUC, it has become apparent that the effect of the rate increase on the paper mill's electricity costs would be significant. We understand that there would be a total increase of 11% in monthly electricity cost (the combined effect of 5.7% increase in the base rate cost and a 5.3% increase in monthly invoices due to the removal of the Tax Cuts and Jobs Act credit).

Pulp and paper manufacturing is highly reliant on reliable and inexpensive electricity to maintain price competitiveness. The nature of the business is such that

the paper mill will typically operate 24/7, meaning that the paper mill will have no way to manage its electrical load to mitigate the increase in demand charges. Given the extremely competitive nature of the pulp and paper manufacturing industry, any significant change in utility costs can lead to changes in business plans and material adverse impacts on profitability, which can, in turn, affect the mill's ability to, among other things, operate effectively and create the job growth it and the residents of Wickliffe so greatly desire. It is abundantly clear that the rate increase proposed by KUC would disproportionately affect the paper mill and thus the community in and around Wickliffe, Kentucky.

As such, Phoenix Paper respectfully requests that the Public Service Commission reject KUC's proposed increase in rates, as the adjusted rates are not fair, just and reasonable in accordance with Kentucky law.
