For the past two weeks, the news has had multiple stories about more rate hikes for LG&E. I just want to inform you, that as a senior living on a very small fixed income, I can't afford it. I walk around my house layered up in the winter, and barely dressed in the summer already. Another increase, and I may as well have my service cut off. Your decisions are surely helping the utility companies increase their profit lines, while making those of us living under the poverty line, have to decide whether we can afford medicines, eat more than once a day if at

all, or even consider selling our homes, and move into some dump of an apartment, in order to survive.

This boards past decisions have already let MSD raise rates so high, that I am seriously having to bathe less, wear clothes three or four days in a row, to cut back on washing them and even reduce the amount of water I drink. Which certainly is not healthy. I am currently paying, because of MSD, roughly seventy-two dollars a month, for 3000 gallons of water. The MSD rate is almost 2.5 times higher for getting rid of the water, than it is for bringing it into my home.

There are too many people that get their service from LG&E that are already struggling each month to make ends meet. Many of them are doing exactly the things I previously mentioned to get by on what little money they have. I am asking for the sake of those like myself, who can not afford another dollar added to their monthly expenses. Help the struggling, for once. Please, do not allow any rate increase for LG&E.
