ORDER

On August 21, 2018, McCreary County Water District (McCreary District) filed a motion requesting that the Commission's June 28, 2018 Order in Case No. 2018-00038¹ be amended. In the June 28, 2018 Order, the Commission authorized McCreary District to enter a lease-purchase agreement with Government Capital Corporation (Government Capital) in the amount of \$781,144.00 at an interest rate not to exceed 3.744 percent per annum to finance the purchase of metering equipment. In this proceeding, McCreary District requests authority to borrow \$797,355.34 from Government Capital at an interest rate not to exceed 3.945 percent per annum.

In support of its motion, McCreary District states that, in its application in Case No. 2018-00038, it erroneously listed the principal amount of the lease-purchase agreement as \$781,144.00, but the actual loan principal was \$797,355.34. On August 23, 2018, an informal conference was held for the purpose of discussing the calculations and evidentiary support for the loan amount. Following the informal conference, McCreary

District filed into the record an amortization schedule to provide evidence to support the higher amount.²

McCreary District further states that market interest rates have risen and, as a result, the interest rate for the proposed loan is now 3.945 percent per annum. In its August 23, 2018 filing, McCreary District provided a second amortization schedule to show the effect of the higher interest rate.³ McCreary District notes that with the increase in the interest rates, the expected benefit of the proposed meters will still produce positive future value savings.⁴

Having considered the motion and being otherwise sufficiently advised, the Commission finds good cause to amend the June 28, 2018 Order in Case No. 2018-00038 to authorize McCreary District to enter a lease-purchase agreement with Government Capital in the principal loan amount of \$797,355.34, and at an interest rate not to exceed 3.945 percent per annum.

IT IS THEREFORE ORDERED that:

- McCreary District's Motion to Amend is granted.
- The case record of Case No. 2018-00038 is incorporated by reference into this proceeding.
- Ordering Paragraph 1 of the June 28, 2018 Order in Case No. 2018-00038
 is amended to read:

- McCreary District is authorized to enter into a leasepurchase agreement with Government Capital in the amount of \$797,356 over a term of ten years at an interest rate not to exceed 3.944 percent per annum.
