## ORDER

On June 28, 2018, the Commission issued an Order in this case, approving *inter alia*, the amounts billed to Louisville Gas and Electric Company's (LG&E) customers through its environmental surcharge for the six-month period ending October 31, 2017. On July 13, 2018, LG&E filed a Motion for Clarification requesting that the Commission expressly approve LG&E's proposed changes to its monthly ES Forms 2.00 and 2.01, as reflected in Exhibit DAR-1 of the Direct Testimony of Derek A. Rahn.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that this case should be reopened, LG&E's Motion for Clarification should be granted, and the June 28, 2018 Order should be amended to approve LG&E's proposal to modify its monthly ES Forms 2.00 and 2.01.
