ORDER

On January 29, 2019, Southern Water and Sewer District (Southern District) filed a motion to strike documents filed by Floyd County Fiscal Court Treasurer David Layne and a response to the Attorney General's motion to supplement his post-hearing brief and. In a January 30, 2019 Order, the Commission denied the Attorney General's motion.

On January 28, 2019, Treasurer Layne filed a 67-page document purporting to demonstrate that Southern District is obligated to reimburse Floyd County Fiscal Court for a \$2,000,000 revenue bond. As explained in the January 30, 2019 Order, Treasurer Layne's filing is not relevant to this proceeding. Neither Treasurer Layne nor Floyd County Fiscal Court are a party to this proceeding, and neither were directed to file the document with the Commission.


Based upon the evidence of record and being otherwise sufficiently advised, the Commission finds that Treasurer Layne's document is a public comment that was inadvertently filed as a response to a data request. For that reason, Southern District's motion to strike should be denied. Additionally, Treasurer Layne's filing should be removed from the case filings and placed in the public comments.

IT IS THEREFORE ORDERED that Southern District's motion is denied.
