ORDER

On August 8, 2018, Duke Energy Kentucky, Inc. (Duke Kentucky), filed its Gas Cost Adjustment (GCA) application to be effective August 29, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Duke Kentucky's application includes revised rates designed to pass on to its customers its expected change in gas costs.
- Duke Kentucky's application sets out an Expected Gas Cost (EGC) of \$3.947 per Mcf.
- Duke Kentucky's application sets out a current quarter supplier Refund
 Adjustment (RA) of (\$.002) and a total RA of (\$.011) per Mcf.
- Duke Kentucky's application sets out a current quarter Actual Adjustment
 (AA) of (\$.345) per Mcf and a total AA of \$.152 per Mcf.
- Duke Kentucky's application sets out a current quarter Balance Adjustment
 (BA) of \$.003 per Mcf and a total BA of (\$.022) per Mcf.
- 6. Duke Kentucky's GCA is \$4.066 per Mcf, which is a decrease of \$.104 per Mcf from its previous GCA of \$4.170 per Mcf.

- 7. Duke Kentucky's application sets out a Gas Cost Adjustment Transition (GCAT) Rider rate of \$.0119 per 100 cubic feet. This GCAT rate will be applicable to customers who begin receiving Rate FT-L transportation service after the effective date of this Order and who paid gas supply costs through the GCA during the 12-month period before they began receiving FT-L service.
- 8. The rates as proposed by Duke Kentucky and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Duke Kentucky on and after August 29, 2018.

IT IS THEREFORE ORDERED that:

- The rates proposed by Duke Kentucky and set forth in the Appendix to this
 Order are approved for final meter readings on and after August 29, 2018.
- 2. Within 20 days of the date of entry of this Order, Duke Kentucky shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 3. This case is closed and removed from the Commission's docket.
