ORDER

On October 15, 2018, Columbia Gas of Kentucky, Inc. (Columbia Kentucky) filed an application to revise its Accelerated Main Replacement Program (AMRP) Rider rates, effective January 2, 2019. Pursuant to an Order entered October 26, 2018, the AMRP Rider was suspended up to and including June 1, 2019. Columbia Kentucky responded to one request for information issued by Commission Staff. There are no intervenors in this proceeding. The case now stands submitted for a decision.

Pursuant to an Order in Case No. 2016-00162,¹ Columbia Kentucky's AMRP Rider is updated annually to reflect the expected impact on Columbia Kentucky's revenue requirements of forecasted net plant additions. Columbia Kentucky tendered its 2019 annual forecasted data to support a forecasted AMRP revenue requirement for 2019 of \$8,035,985. Based upon the forecasted AMRP revenue requirement, Columbia Kentucky proposed to increase its current rates as reflected in the Appendix to this Order.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that Columbia Kentucky's proposed AMRP Rider rates are reasonable.

IT IS THEREFORE ORDERED that:

- The AMRP rates in the Appendix to this Order are approved for service rendered by Columbia Kentucky on and after January 2, 2019.
- 2. Within 20 days of the date of this Order, Columbia Kentucky shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved in this Order and reflecting that they were approved pursuant to this Order.
 - 3. This case is now closed and removed from the Commission's docket.
