

Martin District, including its Chair and Treasurer of its Board of Commissioners, and Martin District's accountant, shall appear at a formal hearing scheduled for February 28, 2018, at 1:00 p.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
