## MOTION FOR EXTENSION OF TIME FOR COMMISSIONER TRAINING

Comes the Martin County Water District (hereinafter District), by counsel, and moves the Public Service Commission for an extension of time for Chairman John Horn, and Commissioner Jaryd Crum, to receive Commissioner training.
