

**RE:** Informal Conference of February 7, 2018

Pursuant to an Order dated February 2, 2018, an informal conference ("IC") was held on February 7, 2018, to allow the parties an opportunity to narrow the issues presented in this proceeding and to discuss Duke Energy Kentucky, Inc.'s ("Duke Kentucky") proposed Offer of Satisfaction . Attached is a copy of the attendance roster.

Commission Staff confirmed that the impact of the reduction in federal corporate income tax rates on Duke Kentucky's rates for electric service will be addressed in Duke Kentucky's pending electric service rate case, Case No. 2017-00321. The impact of the reduction in federal corporate income tax rates on Duke Kentucky's rates for natural gas will be addressed in this proceeding.

The parties had an extensive discussion of the issues, but there was no unanimous agreement on a resolution.

There being no further discussion, the IC was then adjourned.
