# 4 <u>BIG RIVERS ELECTRIC CORPORATION'S MOTION TO CONTINUE TO</u> 5 <u>HOLD REMAINING PROCEDURAL DEADLINES IN ABEYANCE</u>

6	Comes Big Rivers Electric Corporation ("Big Rivers"), by counsel, and
7	respectfully moves the Kentucky Public Service Commission ("Commission") for an
8	order continuing to hold the remaining procedural deadlines in abeyance. In
9	support of this motion, Big Rivers states as follows:
10	On August 10, 2018, Big Rivers filed a motion to hold this matter in abeyance
11	and for a status conference, in order to allow the parties time to attempt to
12	negotiate a settlement of the remaining issues in the proceeding.
13	On August 17, 2018, the Commission entered an order granting Big Rivers'
14	August 10, 2018, motion to hold this matter in abeyance and for a status conference.
15	In that order, the Commission ruled that this matter would be held in abeyance for
16	30 days from the date of the order and that a formal status conference would be
17	held on October 2, 2018.
18	Big Rivers, the Attorney General, and Kentucky Industrial Utility
19	Customers, Inc. have reached a tentative unanimous settlement of all remaining
20	issues; however, the parties have not yet finalized a settlement agreement. The

parties are diligently working to finalize that agreement, and Big Rivers believes it
is likely that the parties will be able to do so prior to the October 2 formal status
conference. Big Rivers therefore requests that the Commission continue to hold this
matter in abeyance until the October 2 formal status conference.

WHEREFORE, Big Rivers respectfully requests that the Commission enter
an order continuing to hold this matter in abeyance until the October 2, 2018,
formal status conference.
