RE: Informal Conferences of February 26 and 27, 2019

Pursuant to an Order issued on February 21, 2019 an informal conference (IC) was held at the Commission's offices in Frankfort, Kentucky, on February 26 and 27, 2019. The IC was held at the request of Kentucky Industrial Utility Customers, Inc. and supported by the Kroger Company and Walmart, Inc. The purpose of the IC was to allow the parties an opportunity to discuss the issues and the possible resolution of issues in these non-consolidated proceedings. An attendance sheet is attached to this memo.

As a result of discussions had at the IC, all parties to these two proceedings, with the exception of Charter Communications Operating, LLC (Charter),¹ were able to come to an agreement resolving nearly all of the issues in these two proceedings. Kentucky Utilities Company and Louisville Gas and Electric Company (jointly "KU/LG&E") filed the Stipulation and Recommendation resulting from the February 26 and 27, 2019 IC on March 1, 2019.
