I received a copy of the letter sent to KU customers regarding the rate increase request. I strenuously object to a rate increase!

KU had a program whereby customers could do energy saving projects on their homes and then would have three (3) years to complete those projects and have their homes reinspected to see what discounts you were qualified for. After we spent in excess of \$15,000.00 (yes I said fifteen thousand dollars) on the suggested improvements to our home, we called to schedule a re-inspection only to be told that the program had ended September 30, 2018. Our contract gave us until 2019 to finish the items needed and get the re-inspection done. A KU employee said that a letter had been sent telling customers that the program plan required you to have the re-inspection done by September 30, 2018. We, along with numerous other KU customers never received this letter. We were told by a KU employer that they had numerous customers that had complained about the program ending before the specified time and the end of the initial contract agreement along with complaints about not received a letter as indicated.

KU promised us a program of discounts if we made improvements to our home and then pulled the plug on numerous customers by ending this program without sufficient notification to its customers. They should not be entitled to a rate increase when they cannot live up to their agreed upon programs.

Dear Public Service Commissioners:

I am writing as a senior, single citizen to oppose rate increase request by Kentucky Utilities Company. The monthly use fee also should be dropped to create incentives to be energy conscientious.

The KU increase adds about 7% to my monthly bills. I would like the Commission and KU to think about ways to create incentives for consumers to be conscientious in our electricity use and to find ways to reduce our usage. Rate increases are unfair given KU's monthly use fees, regardless of how much or how little I use.

One idea I'd like to offer is dropping the monthly minimum fee that KU charges. There are several months when I am caring for an elderly parent and stay with her. But it doesn't matter how much electricity I do or don't use, I'm still hit with a monthly minimum fee.

I'd like to propose that that monthly fee be dropped instead of the latest KU adjustment of rates and charges. I'm perfectly happy to pay for the electricity I use and I understand there are certain charges to equipment, production, operations - but I am tired of getting hit with a minimum fee every month even though I am a conscientious and careful energy consumer. It's time to get rid of the minimum monthly fees which hit us careful consumers unfairly, and create a disincentive for us to be wise electricity users.

Thank you for the opportunity to comment. As a Public Service Commission, please consider ways to create positive energy saving incentives. Minimum monthly fees do not create energy usage incentives.
