NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

(Complete All Shaded Areas and Check Applicable Boxes)

In accordance with 807 KAR 5:001, Section 8, <u>Duke Energy Kentucky</u>, Inc. gives notice of its intent to file an application for <u>an Order to Enter Into Up to \$25,000,000 Capital...</u> with the Public Service Commission no later than <u>October 1, 2018</u> and to use the electronic filing procedures set forth in that regulation.
