RE: Owen Electric Cooperative ("OEC") proposed Advanced Metering System ("AMS") Opt-Out Tariff.

Dear Ms. Pinson:

Attached for electronic filing are OEC's revised tariff sheets that are necessary to include a provision for an OEC Member-Owner to opt out of OEC's AMS. The AMS Opt-Out Tariff is not available to a Member who receives service through an instrument rated meter or who is subject to any of the following OEC tariffs, which require an AMS meter: 1) Off-Peak Marketing; 2) Time of Day; 3) Prepay Metering; 4) Net Metering; 5) Cogeneration; 6) Interruptible Service; or 7) Demand Side Management – Direct Load Control.

Cost Justification for AMS Opt-Out Tariff

Owen Electric Cooperative's ("OEC") current tariff includes a Collection Charge, a Reconnection Charge, and a Disconnection Charge each in the amount of \$30. These fees were established by Order of the Kentucky Public Service Commission ("KPSC") dated June 25, 2008, in Case No. 2008-00154. The Cost Justification Sheet prepared by OEC in Case No. 2008-00154 to support these non-recurring charges is attached hereto as Exhibit 3, Page 2 of 2. As shown on Page 2 of 2, OEC determined the actual cost of each service to be \$36.53; however, OEC requested that a \$30 charge be approved. The KPSC agreed and allowed the \$30 charge even though it was below OEC's actual cost.

As shown on Exhibit 3, Page 2 of 2, the \$30 charge authorized in Case No. 2008-00154 was based on OEC's operating costs for the year ended December 31, 2007. Also, Page 2 of 2 shows that OEC assumed each service for which a \$30 charge would be collected required 30 minutes of time worked by a Field Service Representative ("FSR") and 15 minutes by a Member Service Representative ("MSR").

Pursuant to OEC's proposed Opt-Out Tariff, an OEC Member may elect to have their communicating meter exchanged for a non-communicating meter. Subsequent to the meter exchange, OEC will manually read the Member's meter in order to perform and complete the Member's monthly billing and collection cycle.

OEC anticipates the meter exchange, and each monthly meter reading and Member account billing and collection service that occurs thereafter, will require an amount of employee time that is not materially different than the employee time identified in Case No. 2008-00154 that is necessary to complete a field collection, a service disconnection, or a service reconnection. Each of these services, including the AMS Opt-Out, similarly require an FSR to visit the Member's meter location to input account information into OEC's electronic metering and accounting system and each service requires that an MSR record multiple transactions to the Member's electronic account. As a result, the cost to provide each service is similar.

At this time, OEC requests that the KPSC accept Exhibit 3, Page 2 of 2, as cost justification for the rates include in OEC's proposed AMS Opt-Out Tariff. These rates include a \$30 charge to be assessed at the time a Member's communicating meter is exchanged for a non-communicating meter and a \$30 charge to be assessed each time the Member's non-communicating meter is read thereafter.

OEC further requests that the KPSC approve the proposed rates as part of the AMS Opt-Out Tariff. Although these rates are less than the actual cost of providing the service, as illustrated on Exhibit 3, Page 2 of 2, they are consistent with the KPSC's Order in Case No. 2008-00154. OEC may request in a future filing that the \$30 rates requested herein be adjusted to the actual cost of providing the AMS Opt-Out Tariff.

Notice of Filing

Owen Electric Cooperative ("OEC") gives notice that it has requested to amend its tariff on file with the Kentucky Public Service Commission ("KPSC") so an OEC Member may opt out of OEC's Advanced Metering System ("AMS"). If approved by the KPSC, a Member participating in the AMS Opt-Out Tariff may elect to have OEC exchange their communicating meter with a non-communicating meter. The AMS Opt-Out Tariff would not be available to a Member who receives service through an instrument transformer rated meter or who is subject to any of the following OEC tariffs: 1) Off-Peak Marketing; 2) Time of Day; 3) Prepay Metering; 4) Net Metering; 5) Cogeneration; 6) Interruptible Service; or 7) Demand Side Management – Direct Load Control.

A Member participating in the AMS Opt -Out Tariff will be subject to the following rates and charges, if approved by the KPSC.

Non-recurring initial set-up fee, due upon meter exchange	\$30
Recurring monthly fee, due simultaneous with monthly usage fees	\$30

The rates contained in the tariff filing, and in this notice, are the rates proposed by OEC. The KPSC may order rates to be charged that differ from the rates proposed by OEC.

OEC will submit the proposed AMS Opt-Out Tariff to the KPSC on October 1, 2018. If approved by the KPSC, the tariff will become effective November 1, 2018, and OEC will then begin accepting AMS Opt-Out Tariff Enrollment Forms from Members.

A person may examine OEC's tariff filing, and any related documents, at the KPSC's offices located at 211 Sower Boulevard, Frankfort, Kentucky 40602, Monday through Friday, 8:00 a.m. to 4:30 p.m. or through the KPSC's website at <u>http://psc.ky.gov</u>. A person may also view the tariff filing and related documents at OEC's main office, located at 8205 HWY 127 North, Owenton, Kentucky 40359.

Comments regarding the tariff filing may be submitted to the KPSC through its website at <u>http://psc.ky.gov</u>, or by mail to the KPSC, P.O. Box 615, Frankfort, Kentucky 40602. Also at this mailing address, a person may submit to the KPSC a timely written request for intervention establishing the grounds for the request including the status and interest of the party. If the KPSC does not receive a written request for intervention within thirty (30) days of the date of this publication, the KPSC may take final action on the tariff filing.

Under Owen Electric's AMS Opt-Out Tariff, certain Members may exchange a communicating meter with non-communicating meter. To be considered for enrollment in the AMS Opt-Out Tariff, please complete this Enrollment Form and return by mail to: Owen Electric Cooperative, Attention: Meter Exchange Program, PO Box 400, Owenton, KY 40359. Additionally, you can email the completed form to meterexchange@owenelectric.com or fax it to 502-484-2661.

Eligibility:

- All Owen Electric Members except for those who receive service through an instrument rated meter or who is subject to any of the following OEC tariffs: 1) Off-Peak Marketing; 2) Time of Day; 3) Prepay Metering; 4) Net Metering; 5) Cogeneration; 6) Interruptible Service; or 7) Demand Side Management Direct Load Control. A communicating meter is required to provide service pursuant to these tariffs.
- Must not have more than three (3) cutoffs for non-payment in a fifteen (15) month period.
- To maintain eligibility in the AMS Opt-Out Tariff, a Member must not exceed three (3) cutoffs for non-payment in a fifteen (15) month period.

Advanced Metering System ("AMS") Opt-Out Tariff

Pursuant to the AMS Opt-Out Tariff, a Member may elect to have Owen Electric replace their communicating meter with a non-communicating meter. The replacement meter may be a solid state meter, which may be a communicating meter that has its communicating equipment deactivated. The AMS Opt-Out Tariff is not available to a Member who receives service through an instrument rated meter or who is subject to any of the following Owen Electric tariffs: 1) Off-Peak Marketing; 2) Time of Day; 3) Prepay Metering; 4) Net Metering; 5) Cogeneration; 6) Interruptible Service; or 7) Demand Side Management – Direct Load Control.

To request a meter exchange, a Member must submit to Owen Electric a completed and signed AMS Opt-Out Enrollment Form obtained from Owen Electric. Members accepted into the AMS Opt-Out Tariff will be assessed the following fees in addition to all other rates and charges that are applicable to the Member's account pursuant to Owen Electric's tariff.

Non-recurring Initial Set-up Charge, Billed Upon Meter Exchange	\$30
Recurring Monthly Fee, Due Simultaneous with Monthly Usage Fees	\$30

Once a Member's communicating meter is replaced with a non-communicating meter, the Member will remain in the AMS Opt-Out for no less than twelve (12) months. A Member desiring the reinstallation of a communicating meter after twelve (12) months must submit to Owen Electric a completed Communicating Meter Acceptance Form obtained from Owen Electric.

Owen Electric reserves the right to refuse to provide, or continue to provide, service pursuant to the AMS Opt-Out Tariff when any of the following circumstances exist:

- 1) the Member has poor credit history;
- 2) the Member denies Owen Electric access to a meter;
- 3) the Member has a history of meter tampering or theft of service; or
- 4) the service connection creates a danger to the Member, the public, or an Owen Electric employee.
