ORDER

The Commission, on its own motion, HEREBY ORDERS that hearings in this matter shall be held as follows:

At the time the notice is mailed or publication is requested, the water utility shall forward a duplicate of the notice and request to the Commission.

13. The Commission, on its own motion, pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), hereby orders a stenographic transcript be made of each hearing by a qualified reporter in addition to the digital video recording.

14. A formal conference with all parties shall be held on Tuesday, June 11, 2019, at 1 p.m. Eastern Daylight Time, in Hearing Room 1 at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, in order for the Commission to explain the procedure to be followed during the hearings. Additionally, the Commission will narrow the issues to be addressed at the hearings. The water utilities need only to produce their respective attorneys-of-record at the formal conference as no witness will be required to attend. Commission Staff will contact participants by electronic mail to provide details for joining the conference by telephone in the event that a water utility's attorney-of-record is unable to attend the formal conference in person.
