2. Responses to post-hearing data requests shall be filed in the record on or before Friday, May 17, 2019.

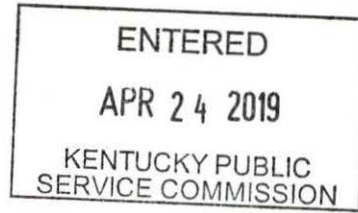

4. The Office of Attorney General may if it desires, file a responsive brief on or before Friday, June 14, 2019.


5. If a brief is filed by the Office of the Attorney General, respondents may file a reply brief on or before Wednesday, June 19, 2019.
