ORDER

The Commission initiated this proceeding for its Commission Staff (Staff) to conduct a review of the 2019 Integrated Resource Plan (IRP) filed by East Kentucky Power Cooperative, Inc. (EKPC), pursuant to 807 KAR 5:058. The Staff Report summarizing Staff's review of the IRP was entered into the record of this case on November 23, 2020, pursuant to 807 KAR 5:058, Section 11(3), and established deadlines for intervening parties to file comments regarding the Staff Report.

Based on the evidence of record, the Commission finds that the Staff Report represents the final substantive action in this matter.<sup>1</sup> The final administrative action will be an Order closing the case and removing it from the Commission's docket. That Order will be issued after the period for comments on the Staff Report has expired.

IT IS THEREFORE ORDERED that:

1. The Staff Report on EKPC's 2019 IRP represents the final substantive action in this matter.

3. An Order closing this case and removing it from the Commission's docket shall be issued after the period for comments on the Staff Report has expired.


