ORDER

On June 21, 2019, Levee Road Water Association, Inc. (Levee Road Water), applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Levee Road Water purchases water from the Mt. Sterling Water and Sewer System (Mt. Sterling).
2. Mt. Sterling notified Levee Road Water that its wholesale rate would increase from \$3.11 per 1,000 gallons to \$3.17 per 1,000 gallons effective July 1, 2019.<sup>2</sup> Levee Road Water proposed to increase the water rates to its customers effective July 1, 2019, to reflect the increased cost of purchased water from Mt. Sterling.
3. Levee Road Water proposed a purchased water adjustment factor of \$0.08 per 1,000 gallons in its application.

4. During the 12 months ended May 31, 2019, Levee Road Water purchased 47,820,600 gallons of water from Mt. Sterling. During the same period, Levee Road Water sold 39,798,598 gallons of water. The increase in the cost of purchased water is \$2,869.24, resulting in a purchased water adjustment factor of \$0.08 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.08 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Levee Road Water's proposed rates should be approved.

7. The rates as set forth in Appendix B to this Order are fair, just, and reasonable, and should be approved for water service rendered by Levee Road Water on and after July 1, 2019.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.08 per 1,000 gallons is approved.

2. The rates proposed by Levee Road Water are approved.

3. The rates set forth in Appendix B to this Order are approved for water service rendered by Levee Road Water on and after July 1, 2019.

4. Within 20 days of the date of entry of this Order, Levee Road Water shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.

5. This case is hereby closed and removed from the Commission's docket.
