## ORDER

This matter arises on written statements filed in this proceeding regarding electronic transmission of Commission Orders and other documents. On September 9, 2019, Kentucky Power Company (Kentucky Power) filed a written statement requesting to receive electronic transmission of Commission Orders and other papers filed in this proceeding pursuant to 807 KAR 5:001, Section 8(9). Kentucky Power included a list of designated persons to receive electronic notice of any documents filed in this proceeding. On September 10, 2019, Kentucky Utilities Company and Louisville Gas and Electric Company (KU/LG&E) filed a similar statement requesting to receive electronic transmission of Commission Orders and papers filed in this proceeding with a list of designated persons to receive electronic notice of any documents filed in this proceeding.

The requests filed by Kentucky Power and KU/LG&E comply with electronic filing procedures applicable to <u>parties</u> to a case. However, this case was established to accept comments, and there are no parties to, or service list for, this case. Because there are no parties to this case, 807 KAR 5:001, Section 8(9), filing procedures are not applicable. Therefore, the Commission finds that filing the written statements does not entitle Kentucky Power or KU/LG&E to receive copies of documents filed in this proceeding using the filing procedures for parties.
