ORDER

On August 2, 2019, Jessamine-South Elkhorn Water District (Jessamine-South Elkhorn District) applied for approval to adjust its rates pursuant to the treated sewage adjustment procedure.¹

Having reviewed the record and being otherwise sufficiently advised, The Commission finds that:

1. Lexington-Fayette Urban County Government (LFUCG) agreed by contract dated January 3, 2003, to treat sewage generated by Jessamine-South Elkhorn District sewer service customers in a designated service area. Pursuant to the contract, sewer user fees are calculated based upon the monthly water use of each of Jessamine-South Elkhorn District's sewer service customers to whom LFUCG provides sewage treatment.
2. LFUCG notified Jessamine-South Elkhorn District on June 10, 2019, its wholesale sewage treatment rate would increase from \$6.12 per 100 cubic feet to \$6.43 per 100 cubic feet effective July 15, 2019.² Jessamine-South Elkhorn District proposed

to increase the sewage rates to its customers effective July 15, 2019, to reflect the increased cost of sewage treatment service from LFUCG.

3. Jessamine-South Elkhorn District proposed a treated sewage adjustment factor of \$0.42 per 1,000 gallons.

4. During the 12-month period that ended June 30, 2019, Jessamine-South Elkhorn District's sewer customers receiving service from LFUCG used 8,176,546.82 cubic feet of water (61,164,822 gallons of water). The increase in the cost of treated sewage is \$25,347.30, resulting in a treated sewage adjustment factor of \$0.42 per 1,000 gallons.³

5. The treated sewage adjustment factor of \$0.42 per 1,000 gallons, as calculated in Appendix A to this Order, permits Jessamine-South Elkhorn District to pass through the increase in its wholesale rates from LFUCG and is fair, just, and reasonable and should be approved.

6. Jessamine-South Elkhorn District's proposed rates should be approved.

7. The rates as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for sewer service rendered by Jessamine-South Elkhorn District on and after July 15, 2019.

IT IS THEREFORE ORDERED that:

1. The treated sewage adjustment factor of \$0.42 per 1,000 gallons is approved.

2. Jessamine-South Elkhorn District's proposed rates are approved.

The treated sewage adjustment factor of \$0.31 per 100 cubic feet converts to a per-1000-gallons adjustment factor of \$0.42 ($\$0.31 \text{ per } 100 \text{ cubic feet} / .748 = \$0.42 \text{ per } 1,000 \text{ gallons}$).

3. The rates as set forth in Appendix B to this Order are approved for sewer service rendered on and after July 15, 2019.

4. Within 20 days of the date of this Order, Jessamine-South Elkhorn District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.


5. This case is hereby closed and will be removed from the Commission's docket.
